

TERMS & CONDITIONS

Football Federation Australia – Westfield Matildas Open Training Session Competition

Win 1 of 3 Major Prizes at the Westfield Matildas Open Training Session (Perth)

1. Information on how to enter and details of the Prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promotion is open to the attendees of the Westfield Matildas Open Training Session on 24 March 2018 at nib Stadium (the **Event**) who correctly complete and submit the competition form to enter the draw (**Entrants**).
3. Employees of the Promoter and their immediate families and agencies directly associated with this promotion are ineligible to enter.
4. To enter, eligible Entrants must provide their name, date of birth, contact number and email address on the competition form.
